**Project to Promote the Use of e-Business in the SME Community**  
***Request for Proposals from Software Vendors***

(Hong Kong, 12 April 2007) The Hong Kong Small and Medium Enterprises Association ("HKSME Association"), Hong Kong Information Technology Federation Limited ("HKITF") and Digital Trade and Transportation Network Limited ("DTTNCo") today announced the launch of a project to promote the use of e-business in the SME community ("Project"). Under the Project, software vendors are invited to submit proposals to develop front-end software for use by SMEs for electronic document preparation and exchanges with their trading partners through the Government-endorsed Digital Trade and Transportation Network ("DTTN"). The Project is funded by the Office of the Government Chief Information Officer ("OGCIO") of the HKSAR Government (the "Government") under the 2006/07 Sector-Specific Programme ("Programme").

The Request for Proposal is opened to all software vendors interested to develop solutions for the SME market. Apart from developing the basic front-end solution for document preparation and exchange via the DTTN platform, vendors can also develop other value-added applications to be used in conjunction with the DTTN. While the basic front-end module can be integrated into the vendors' other value-added applications, it must be operable on a standalone basis and will be made available for free to SMEs.

Danny Lau, Chairman of HKSME Association said, "We are delighted to participate in the Project, which will ultimately benefit the SME community in the trade and logistics industry". Simon Shi, President of the HKSME Association added, "Through this Project, an extensive portfolio of simple front end solutions will be made widely and freely available for use by SMEs for preparing and exchanging business documents with their trading partners via the DTTN platform. The SME community will enjoy the real benefits of e-business using DTTN."

"This is an exciting project for the IT industry. Besides receiving the seed capital to develop the basic front-end solutions for SMEs, the biggest benefit is the new business opportunity arises for the software vendors with their solutions being connected to the DTTN platform. For the trade and transportation industries, we are also pleased to contribute the value of IT in their business operations." Judy Leung, Vice President of HKITF added.

The deadline for proposal submission is 18 May, 2007. About 10 proposals will be awarded the seed capital of HK\$80,000 each for the development of the basic front-end module. Justin Yue, Chairman of DTTNCo, concluded, "The DTTN was initiated by the Government, with the vision to strengthen the role of Hong Kong as the preferred international and regional logistics hub through an open, neutral, secure and reliable community e-platform that facilitates electronic information flow along the supply chain. It aims to be a catalyst to promote e-business adoption, especially by the SMEs. As stated by OGCIO, main objective of the Programme is to drive e-business and ICT adoption in the traditional business sectors, targeting at the SMEs. Through this Project, we hope that the general e-readiness of the SMEs will be further enhanced, which in turn will benefit the IT sector with more business opportunities to offer more value-added solutions to these SMEs."
